



## Thai Chicken with Rice and Vegetables

**SE/DK/NO Ingredienser:** Ris 37%, grönsaker 26% (morot/gulerod, gröna bönor/bønner, majs, röd paprika/röd peberfrugt, lök/løg), kyckling/kylling 10%, palmfett, kokosmjölk/kokosmælk, **gräddpulver/flødepulver**, salt, modifierad potatisstärkelse/kartoffelstivelse/potetstivelse, maltodextrin, socker/sukker, arom/aroma, jästextrakt/gærekstrakt, **mjolkprotein/mælkeprotein**, syra: citronsyra, kryddor/krydderier, korianderextrakt, rismjöl/rismel.

**EN Ingredients:** Rice 37 %, vegetables 26 % (carrot, green beans, sweetcorn, red pepper, onion), chicken 10 %, palm fat, coconut milk, **cream** powder, salt, modified potato starch, maltodextrin, sugar, flavouring, yeast extract, **milk protein**, acid: citric acid, spices, coriander extract, rice flour.

**FR Ingrédients:** Riz 37%, légumes 26% (carottes, haricots verts, maïs, poivron rouge, oignon), poulet 10%, graisse de palme, lait de coco, **crème** en poudre, sel, amidon modifié de pomme de terre, maltodextrine, sucre, arôme, extrait de levure, protéines de **lait**, acide: acide citrique, épices, extrait de coriandre, farine de riz.

**Claims :** Gluten free

**Category:** Dry meal

### Preparation:

1 Tear off the top and fold out the bottom

2 Add 400 ml of boiling water (level H)

3 Stir

4 Re-seal, wait 10 mins

Add more water if required.

Can be prepared using cold water, extend the time to > 30 mins

**Content:** 139 g

**Shelf life:** 60 months at an ambient temperature in a temperate climate or according to NATO Standard AMedP-1.11; Chapter 2.4. – Shelf Life.

**Storage:** Dry at room temperature.
