



Wilderness Stew with Rice

SE/DK/NO Ingredienser: Ris 40%, vegetabiliskt fett (palmfett, rapsolja/rapsolie), potatis/kartoffler/poteter, glukossirap, nötkött/oksekød/storfekjøtt 7,0%, gröna bönor/bønner, modifierad potatisstärkelse/kartoffelstivelse/potetstivelse, **gräddpulver/flødepulver**, svamp/sopp (champinjon/sjampinjong, Karljohan/spiselig rørhat/steinsopp), salt, maltodextrin, jästextrakt/gærestrakt, lök/løg, renkött/rensdyrkød/reinkjøtt 0,7%, arom, köttextrakt/kødekstrakt, persilja/persille, kryddor/krydderier, rosmarinextrakt.

EN Ingredients: Rice 40 %, vegetable fat (palm fat, rapeseed oil), potato, glucose syrup, beef 7.0 %, green beans, modified potato starch, **cream** powder, mushrooms (champignon, Karl Johan), salt, maltodextrin, yeast extract, onion, reindeer meat 0.7 %, flavouring, meat extract, parsley, spices, rosemary extract.

FR Ingrédients: Riz 40%, graisse végétale (graisse de palme, huile de colza), pomme de terre, sirop de glucose, bœuf 7,0%, haricots verts, amidon modifié de pomme de terre, **crème** en poudre, champignons (champignon de Paris, cèpe), sel, maltodextrine, extrait de levure, oignon, viande de renne 0,7%, arôme, extrait de viande, persil, épices, extrait de romarin.

Claims: Gluten free

Category: Dry meal

Preparation:

1 Tear off the top and fold out the bottom

2 Add 350 ml of boiling water (level G)

3 Stir

4 Re-seal, wait 10 mins

Add more water if required.

Can be prepared using cold water, extend the time to > 30 mins

Content: 144 g

Shelf life: 60 months at an ambient temperature in a temperate climate or according to NATO Standard AMedP-1.11; Chapter 2.4. – Shelf Life.

Storage: Dry at room temperature.
